# **Executive Summary**

## A Budget Appropriation Ordinance to Support the Mayor's Office of the National Western Center

The proposed ordinance will establish \$1,335,500 budget for 2016 operations of the new Mayor's Office of the National Western Center through an appropriation of General Fund contingency. This budget is comprised of \$585,500 for staff and office operating costs and \$750,000 for planned legal expenses in 2016. This budget will support the delivery of the \$856M National Western Center project (including City, RTA and partner funds), as approved by voters in the 2015 2C ballot measure.

## Proposed 2016 NWCO Operating Budget: \$585,500

- 1) \$369,000 for personnel services
- 2) \$124,500 for services and supplies
- 3) \$92,000 for NDCC/NWCO Assistant City Attorney

*Note: NWCO operating budget anticipated to increase for the 2017 budget to consolidate existing staff and consultant resources currently assigned to 2016 NDCC budgets.* 

## Proposed Budget for 2016 Legal Services: \$750,000

- 1) \$292,500 for legal services provided by Kaplan, Kirsch and Rockwell (governance counsel)
- 2) \$165,000 for legal services provided by Hogan Lovells (governance, naming rights and site operations counsel)
- 3) \$292,500 for legal services provided by Butler Snow (governance counsel)

The City Attorney's Office used a competitive selection process in 2015 to select a team of outside counsel who will identify and provide advice regarding the governance of the National Western Center, including work related to entity form and structure, composition and procedures of the board of the entity, leadership and powers of the staff of the entity, and transitioning control of the NWC to the entity. Outside counsel will also provide advice regarding the City's legal relationship with the entity and the other partners at NWC, including issues regarding operations and maintenance, capital funding participation, leases, and construction. In addition to these governance topics, outside counsel will be involved in the creation, marketing, valuation of naming rights and campus operations at the National Western Center. Additional budget for outside legal counsel will be requested for the 2017 budget.
