- With the creation of the North Denver Cornerstone Collaborative (NDCC) in 2013, the City brought six large independent projects together, strategically aligned their planning to create synergies and drive a sense of responsibility, excitement and urgency for implementation in three historically underserved neighborhoods.
- Following the successful 2C ballot measure in 2015, the Mayor's Office of the National Western Center (NWCO) was created to coordinate the delivery of the National Western Center project with City Council, the Citizen's Advisory Committee, National Western Center MOU partners and all City agencies.
- NWCO will continue to coordinate with the NDCC projects and team.

NWC 10 year Project Costs (Phases 1 & 2) \$856 million:


- Land site remediation and infrastructure
- New stockyards and events pavilion
- New Livestock center
- New Equestrian Center and Equine Sports Medicine & Rehabilitation Clinic
- River Activation
- NWC segment of Brighton Blvd
- Neighborhood connectivity (streets, bridges)
- This amount does not include the proposed new Expo Hall, Arena, CSU academic buildings (funded by the State of Colorado).

NWC Source of Funds

\$856 million:


- \$668.5 million from the City of Denver
 - \$476 million from excise tax revenue bonds
 - \$192.5 million balance will be delivered to the project over ten years from land/asset sales, on-site revenues, capital and wastewater funds and federal grants.
- \$121.5 million from the State of Colorado Regional Tourism Act funds (awarded 12/10/15)
- Minimum of \$16 million from CSU (COP funding) for Equine Sports Medicine & Rehabilitation Clinic
- \$50 million cash contribution from the NWSS






National Western Center Citizens Advisory Committee (2013-present)

NDCC-NWCO Portfolio Coordination




NDCC-NWCO Shared Resources: Organizational Alignment


