DESCRIPTION

Commencing at the northeast corner of said section 16 (monumented with a found stone with chiseled "+" in Range Box) thence S86°17'32"W, a distance of 827.04 feet to a point on the easterly line of said official channel of the South Platte River, said point also being on the south right-of-way line of West Alameda Avenue as described in Ordinance No. 48, Series 1908, and the POINT OF BEGINNING;

- 5. Thence on the arc of a curve to the left non-tangent to the previous course, a radius of 750.00 feet, a central angle of 00°56'03", a distance of 12.23 feet, (a chord bearing N20°31'28"W, a distance of 12.23 feet) to a point on said south right-of-way line of West Alameda Ave.:
- 6. Thence along said south right-of-way line of said West Alameda Ave., N89°45'30"E, a distance of 159.35 feet, more or less, to the POINT OF BEGINNING.
