Synopsis:

This study is the result of a request by the Denver Police Department. It is requested to create two new classifications, the Police Video Operator and Lead Police Video Operator. Incumbents are responsible to monitor live video and to store and access video recordings, and to store data recorded from police officer body cameras. These videos are often used as evidence during investigations and for court cases.

Pay Rationale:

Market data was collected from a custom survey of national and local police departments. Of the 42 surveys sent out, 17 responses were received with five indicating a match. National data was adjusted to the Denver market using a cost-of-living factor for each response. Only civilian positions were used in the analysis; any organization's response of sworn was omitted in the analysis. Two central tendency measures were calculated for each position surveyed: simple average and median for the average pay rate, range minimum, range midpoint, and range maximum.

The Police Video Operator, the entry to the classification series, will be used to set the pay grades for the Lead Police Video Operator as well. It is recommended to set the pay for the Police Video Operator at pay grade 613-N. This is based on the custom survey data, which indicates that the midpoint of pay grade 613-N, \$43,887, is 2.1% less than the weighted market average, \$44,837 and 5.6% greater than the market median \$41,572. This is an excellent match between the market data and pay grade 613-N.

Next, for the Lead Police Video Operator, we will use the compensation practice to pay provide a one pay grade difference for a lead worker classes in a series. It is recommended to pay this classification 614-N since this class will be assigned permanent leadwork over the Police Video Operators.

Employee Impact:

These are new classes. Seven current incumbents classified as Security Officer in this division will be reallocated to the Police Video Operator.

Budget Impact:

These are new classes. The cost to move seven incumbents from the Security Officer, 609-N, to the Police Video Operator, 613-N is \$15,784.2, which is the cost to move them to the range minimum of the new pay grade.

Organizational Data:

These classes report to an Operational Supervisor I who reports to a Sergeant, who reports to the chain of command up to the Police Chief.

Effective Date Rule:

If it is determined, as a result of an audit or maintenance study, that changes to the classification and pay plan are necessary, the effective date of any resulting changes to the classification and pay plan shall be the beginning of the first work week following approval by the Mayor or by the City Council over the Mayor's veto. Provisional classifications

resulting from changes to the classification and pay plan may be used upon approval by the Board, but use for longer than six months is contingent upon City Council approval.
