Benefits: To provide payroll and HR services for IATSE Local #7 stagehands in all Arts & Venues Denver facilities. The stagehand payroll services provider negotiates with the stagehand union and administers all payroll and HR Services for these employees. The contract was competitively bid in 2008 and awarded to SMG, the manager of the Colorado Convention Center (CCC). Depending on the amount of activity in the venues, the contract provider incurs \$4.5M-\$5M in stagehand payroll expenditures per year, which are reimbursed by the agency. AVD in turn invoices customers who use the stagehands for events in the venues and is reimbursed by those customers. This is largely a pass through expenditure for the agency. f.
