Dear Landmark Commissioners,

On behalf of Historic Denver's Board of Trustees, I am writing to offer our support for the local historic designation of the Allen Ghost House at 1899 York.

In February 2015, Historic Denver received notice that the previous owners of 1899 York had submitted an application for a Certificate of Non-Historic Status. This residence, which sits across from City Park on a well-traveled thoroughfare, is an impressive structure, one which merited further conversation between the owners and the community. Further research indicated that the home was designed by architect Harry Manning and built for one of Denver most famous real estate developers, Allen Ghost. These details, combined with the home's prominent location directly across from City Park, made it a clear candidate for local landmark designation. The City Park West neighborhood was active in supporting the preservation of this building, and after several meetings with Historic Denver, our board and other neighbors, the previous owners of 1899 agreed to withdraw their application. Ultimately, they sold it to the current owner who is demonstrating his commitment to preservation with this designation application.

The successful preservation of this home along York Street serves as an important anchor for the entire block adjacent to City Park and the surrounding neighborhood. Together with the recent renovation of the former Le Peep restaurant and the Parkside Mansion, this block will retain its historic parkway character, which serves as a transition between the park and the residential area to the west. This designation will also allow the new owner to qualify for historic tax credits to rehabilitate this building and make it a stunning example of the Mission Revival style once more.

Historic Denver would like to congratulate the new owner of the Ghost House on this step forward, and encourage the Landmark Preservation Commission to approve this landmark application, to ensure the preservation of this most deserving historic building.

To Whom It May Concern:

Traditional architecture is the cultural fabric of Denver's neighborhoods. Preserving fine examples adds much to the quality of life in our community, and is especially important during times of rampant growth, such as Denver is experiencing now. Landmark Designation is an important tool that should be used to recognize the cultural value of such buildings.

The Ghost/Rose house at 1899 York Street was designed by one of Denver's great architects, Harry James Manning and constructed in 1906. It is a fine example of the Mission Revival style. From History Colorado's *Architects Biographical Series*: "Like many architects of this period, Manning designed in a wide variety of historical revival styles, including Spanish Colonial Revival, Tudor Revival, Collegiate Gothic, and Neo-Classical Revival. He traveled extensively in later years and this first-hand exposure to various architectural types is reflected in his work. His prolific body of work, distinguished by his knowledgeable use of details and materials, has been described as 'graceful, well-proportioned, and above all, in good taste' (Noel & Norgren 1987:210)."

Our chapter supports the application for Landmark Designation by the new owner of 1899 York Street, Mr. Ryan Rose and I respectfully urge you to vote "yes" to grant the Landmark Designation. Thank you very much.
