

Beginning at a point on the east line of Lot 24, Block 48, Evanston Third Filing that is 5 feet south of the northeast corner; thence southwesterly to a point that is 15 feet south of the north line and 10 feet west of the east line of said Lot 24; thence east on a line parallel with and 15 feet south of the north line of said Lot 24 to a point on the east line 15 feet south of the northeast corner of said Lot 24; thence north on the east line of said Lot 24 a distance of 10 feet to the Point of Beginning.
