## A RESOLUTION

## Accepting and approving the plat of Stapleton Filing No. 49.

WHEREAS, the property owners of the following described land, territory or real property situate, lying and being in the City and County of Denver, State of Colorado, to wit:

A part of the Northwest Quarter and a part of the Southwest Quarter of Section 10, Township 3
South, Range 67 West of the Sixth Principal Meridian, City and County of Denver, State of Colorado, more particularly described as follows:

COMMENCING at the Northwest Corner of said Section 10;

thence along the arc of a curve to the right having a radius of 2116.00 feet, a central angle of $20^{\circ} 32$ '10", an arc length of 758.42 feet and whose chord bears South $15^{\circ} 02^{\prime} 36$ " East a distance of 754.37 feet;
thence South $45^{\circ} 15^{\prime} 25^{\prime \prime}$ East a distance of 9.75 feet;
thence North $89^{\circ} 44^{\prime} 35^{\prime \prime}$ East a distance of 20.77 feet;
thence South $04^{\circ} 02^{\prime} 14$ " East a distance of 38.08 feet;
thence South $89^{\circ} 44^{\prime} 35$ " West a distance of 17.88 feet;
thence South $44^{\circ} 44^{\prime} 35^{\prime \prime}$ West a distance of 12.37 feet to a point of non-tangent curve;
thence along the arc of a curve to the right having a radius of 2116.00 feet, a central angle of $32^{\circ} 15^{\prime} 52^{\prime \prime}$, an arc length of 1191.56 feet and whose chord bears South $12^{\circ} 48^{\prime} 46$ " West a distance of 1175.88 feet;
thence South $60^{\circ} 46$ '26" East a distance of 27.03 feet;
thence South $29^{\circ} 13{ }^{\prime} 34$ " West a distance of 38.00 feet;
thence North $60^{\circ} 46^{\prime} 26$ " West a distance of 22.00 feet;
thence South $29^{\circ} 13^{\prime} 34^{\prime \prime}$ West a distance of 87.85 feet to a point of curve;
thence along the arc of a curve to the left having a radius of 761.00 feet, a central angle of
$24^{\circ} 13^{\prime} 34^{\prime \prime}$, an arc length of 321.77 feet and whose chord bears South $17^{\circ} 06^{\prime} 47^{\prime \prime}$ West a distance of
319.38 feet;
thence South $05^{\circ} 00^{\prime} 00^{\prime \prime}$ West a distance of 348.72 feet to a point of curve;
thence along the arc of a curve to the left having a radius of 479.00 feet, a central angle of $5^{\circ} 15^{\prime} 25^{\prime \prime}$, an arc length of 43.95 feet and whose chord bears South $02^{\circ} 22^{\prime} 18^{\prime \prime}$ West a distance of 43.93 feet;
thence South $00^{\circ} 15^{\prime} 25^{\prime \prime}$ East a distance of 142.52 feet to a point of curve; thence along the arc of a curve to the left having a radius of 34.00 feet, a central angle of $11^{\circ} 13^{\prime} 38$ ", an arc length of 6.66 feet and whose chord bears South $05^{\circ} 52^{\prime} 14^{\prime \prime}$ East a distance of 6.65 feet to the southerly line of TK-9A (LA-9A) described at Reception Number 2010075685 in the Clerk and Recorder's Office of said City and County of Denver; thence South $89^{\circ} 29^{\prime} 45$ " West, along said southerly line of TK-9A (LA-9A) described at Reception Number 2010075685, a distance of 1676.89 feet to the southwest corner of said TK-9A (LA-9A) described at Reception Number 2010075685, said southwest corner also being a point 50.00 feet easterly of the westerly line of said Southwest Quarter of Section 10; thence North $00^{\circ} 15^{\prime} 25$ " West, parallel with and 50.00 feet easterly of said westerly line of the Southwest Quarter of Section 10, a distance of 2578.58 feet to a point 50.00 feet easterly of said westerly line of the Northwest Quarter of Section 10;
thence North $00^{\circ} 15^{\prime} 13$ " West, parallel with and 50.00 feet easterly of said westerly line of the Northwest Quarter of Section 10, a distance of 546.44 feet to the POINT OF BEGINNING.

Containing 6,892,426 square feet or 158.228 acres, more or less.
BASIS OF BEARING: Bearings are based on the west line of the Southwest Quarter of Section 10, Township 3 South, Range 67 West of the Sixth Principal Meridian, City and County of Denver, State of Colorado, bearing North $00^{\circ} 15^{\prime} 25$ " West based on NAD 83/92 Colorado Central Zone State Plane Coordinates. The Southwest Corner of said Section 10 is a Found 3-1/4" Aluminum Cap in Monument Box Stamped PLS 27936. The West Quarter Corner of said Section 10 is a Found 3-1/4" Aluminum Cap in Monument Box Stamped: ZBS INC PLS 11434.
propose to lay out, plat and subdivide said land, territory or real property into blocks, lots and tracts, and have submitted to the Council of the City and County of Denver a plat of such proposed subdivision under the name and style aforesaid, showing the adjacent streets and platted territory, accompanied by a certificate of title from the attorney for the City and County of Denver;

WHEREAS, said subdivision was surveyed by or under the direction of the City Engineer of the City and County of Denver and said City Engineer has certified as to the accuracy of said survey and said plat or map and their conformity with the requirements of Chapter 49, Article III of the Revised Municipal Code of the City and County of Denver, and said plat has been approved by the City Engineer, the Executive Director of Community Planning and Development, the Executive Director of Public Works and the Executive Director of Parks and Recreation;

## NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the Council hereby finds and determines that said land, territory, or real property has been platted in strict conformity with the requirements of the Charter of the City and County of Denver.

Section 2. That the said plat or map of Stapleton Filing No. 49 be and the same are hereby accepted by the Council of the City and County of Denver.
