<u>A BILL</u>			
For an ordinance changing the zoning classification for 12680 E. Albrook Drive in Montbello.			
WHEREAS, the City Council has determined, based on evidence and testimony presented			
at the public hearing, that the map amendment set forth below conforms with applicable City laws,			
is consistent with the City's adopted plans, furthers the public health, safety and general welfare of			
the City, will result in regulations and restrictions that are uniform within the OS-A district, is justified			
by one of the circumstances set forth in Section 12.4.10.8 of the Denver Zoning Code, and is			
consistent with the neighborhood context and the stated purpose and intent of the proposed zone			
district;			
NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF			
DENVER:			
Section 1. That upon consideration of a change in the zoning classification of the land area			
hereinafter described, Council finds:			
a. The land area hereinafter described is presently classified as S-MX-12.			
b. It is proposed that the land area hereinafter described be changed to OS-A.			
Section 2. That the zoning classification of the land area in the City and County of Denver			
described as follows shall be and hereby is changed from S-MX-12 to OS-A:			
Legal Description			
A part of Lot 7, Block 1, Koll Peoria Center Filing No. 1, being a subdivision situated in the Northwest Quarter of Section 24, Township 3 South, Range 67 West of the Sixth Principal Meridian, City and County of Denver, State of Colorado, according to the plat thereof recorded in the City and County of Denver Clerk and Recorder's Office at Reception Number 9900000721, more particularly described as follows: Commencing at a range point in Albrook Drive, being on a 20 foot range line, as monumented by a recovered 3-1/4" aluminum cap in a range box, stamped, "PLS 37993", whence a range point in said Albrook Drive, Being on a 20 foot range line and a point of curvature, as monumented by a recovered #8 rebar in a range box, bears S68°00°00"E, a distance of 414.81 feet, forming the basis of bearing used in this description with all bearings being relative thereto: Thence departing and perpendicular to said 20 foot range line, S22°00'00"W, a distance of 50.00 feet to a point on the southerly right-of-way line of Albrook Drive, said point also being the most northerly boundary corner of said Lot 7;

- 2 being 50.00 feet southwesterly of and parallel with said 20 foot range line, the following two3 courses:

 central angle of 11°34′03″, a radius of 965.00 feet and an arc length of 194.83 feet to the

- 10 Thence departing said southerly right-of-way line and along the exterior boundary of said Lot 7 11 the following eight courses:
- 12 1) \$40°30'09"W, a distance of 150.00 feet;
- 13 2) \$52°05'31"E, a distance of 133.14 feet;
- 14 3) \$49°30'02"E, a distance of 125.00 feet;
- 15 4) \$40°29'58"W, a distance of 60.00 feet;
- 16 5) S29°59'56"W, a distance of 98.77 feet;
- 17 6) S40°29'58"W, a distance of 9.00 feet to a point of curvature;
- 7) Along a tangent curve to the right having a central angle of 49°30'00", a radius of 245.00 feet
 and an arc length of 211.66 feet;
- 20 8) S90°00'00"W, a distance of 441.91 feet to the southwest boundary corner of said Lot 7;
- Thence along a westerly boundary line of said Lot 7, N00°00′00"E, a distance of 275.67 feet;
- Thence departing and perpendicular to the last described course, S90°00'00"E, a distance of
 283.86 feet;
- 24 Thence N22°00'00"E, a distance of 124.39 feet;
- 25 Thence perpendicular to the last described course, S68°00′00"E, a distance of 33.70 feet;
- Thence perpendicular to the last described course, N22°00′00"E, a distance of 231.67 feet to the
