## THIRD AMENDATORY AGREEMENT

**THIS THIRD AMENDATORY AGREEMENT** is made and entered into by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the "City"), and **STAR TELECOMMUNICATIONS, INC.**, a Colorado corporation, doing business at 7717 West 6<sup>th</sup> Avenue, Unit B, Lakewood, Colorado 80214 (the "Contractor"), collectively "the Parties."
