**A BILL**

**For an ordinance amending Section 39-121 of the Revised Municipal Code of the City and County of Denver regarding the Schedule for Use of Facilities, specifically for the Carla Madison Recreation Center Rooftop Event Space.**

**BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** Section 39-121 of the Denver Revised Municipal Code is amended by adding subsection (23) to read as follows:

“(23) Carla Madison Recreation Center Rooftop fees:

<u>1.</u>	<u>Monday through Thursday hourly rate (2-hour minimum)</u>	<u>\$150.00</u>
<u>2.</u>	<u>Friday through Sunday and holidays (6-hour block)</u>	<u>1,500.00</u>

Holidays include Martin Luther King, Jr. Day, President’s Day, Memorial Day, the week of Fourth of July, Labor Day, Thanksgiving Day, Christmas Eve, Christmas Day, New Year’s Eve and New Year’s Day.”
