25	Special Revenue Fund No. 11000, which is set forth and	d described in Section 20-18 of the Revised	
26	Municipal Code of the City and County of Denver.		
27	Section 3. Program expenditures are hereby a	authorized for the "2020 Census Fund",	
28	Accounting No. 11869, in the amount not to exceed the	total of deposits described in Section 2 of	
29	this ordinance expended by the Director of Human Rights	s and Community Partnerships. Authorized	
30	expenditures for Accounting No. 11869 include but are not limited to the cost of outreach,		
31	engagement, and marketing efforts to conduct a full and	accurate count of the population of the City
