21	Series, Accounting No. 11000, a "2020 Census Fund", Accounting No. 11869, for the purpose of			
22	accounting for the receipt and expenditure of Census	program dollars.		
23	Section 2. Monies received from transfers from	other City funds, donations, and other sources		
24	of revenue for Accounting No. 11869 shall be deposit	ed into the Treasury of the City and credited to		
25	Special Revenue Fund No. 11000, which is set forth	and described in Section 20-18 of the Revised		
26	Municipal Code of the City and County of Denver.			
27	Section 3. Program expenditures are hereb	y authorized for the "2020 Census Fund",		
28	Accounting No. 11869, in the amount not to exceed	the total of deposits described in Section 2 of		
29	this ordinance expended by the Director of Human Ri	ghts and Community Partnerships. Authorized		
30	expenditures for Accounting No. 11869 include b	out are not limited to the cost of outreach,		
31	engagement, and marketing efforts to conduct a full and accurate count of the population of the City			
32	and County of Denver in the 2020 Census. This is a	cash basis, non-lapsing fund.

2	and directed to make such book and record entries and to do such other things as may be necessary
