6 **For an ordinance making a rescission, cash transfers, and supplemental**  
7 **appropriations from the General Fund to Capital Improvement Project Funds.**

9 **WHEREAS**, the Department of Public Works has assessed current needs and available  
10 capacity in its 2018 General Fund appropriation; and

11 **WHEREAS**, the Department of Public Works wishes to use available capacity to install 44  
12 street lights along Tower Road from Pena Boulevard to 80<sup>th</sup> Avenue and to fund irrigation on the  
13 Colfax/Lipan intersection project;

15 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**

18 **Section 1.** From appropriations heretofore made from the General Fund listed or indicated in  
19 the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation  
20 under the heading "Amount Rescinded" and transferred to the General Fund:

25 hereby appropriated to the appropriation accounts hereinafter designated the amount of money  
26 following such designation, to be expended for the purposes and upon the authorizations in said

 5 amount of money, following such designation, to be expended for the purposes and upon the  
 6 authorizations in said Ordinance set forth:
