Dear Mayor and City Council:

This law firm represents numerous licensed professionals including physicians, nurses, psychologists, counselors, mental health professionals, therapists, pastors, and others, some of whom are engaged in new, emerging, non-traditional, holistic, and even controversial, medical treatments or therapy. This firm also represents patients, or parents of patients, who receive or are involved in such medical services. These treatments sometimes depart from the prevailing Establishment popular orthodoxy.

The proposed Bill noted above, and titled "Prohibition of Conversion Therapy," raises serious constitutional concerns, as it essentially involves a prohibition and prior restraint against speech, but only discriminates against speech of certain viewpoints. The proposed ordinance would violate the First Amendment to the U.S. Constitution, if enacted.

Statements made during confidential doctor-patient or other medical consultations are free speech and are protected by the First Amendment. See National Institute of Family and Life Advocates (NIFLA) v. Beccera, 585 U.S. (U.S. Supreme Court June 26, 2018); Conant v. Walters, 309 F.3d 629 (9th Cir. 2002) (physician recommendation of medical marijuana, even if recommended

substance is federally-illegal, protected under First Amendment as free speech and cannot be penalized).

This bill prohibits constitutionally-protected speech, by injecting State interference into the subjects or treatment objectives of privileged treatment or medical discussions. This proposed law authorizes State coercion and punishment, all against mere words, with such State force triggered from an *anonymous* complaint, adjudicated by a lone unelected and unaccountable bureaucrat, with no rules of evidence, no rules of procedure, no due process, no jury, no ability to question the motives of, or even face, the accuser(s), and no mechanism to remedy or penalize frivolous or false allegations.

Moreover, the bill also violates the constitutional right of a parent to parent a child without State interference. See Troxel v. Granville, 530 U.S. 57, 65 (2000). Colorado law contains a presumption that a parent acts in the best interests of his or her child. In Re Parental Responsibilities of B.J., 242 P.3d 1128, 1132, 1135 (Colo. 2010). This bill substitutes the government for the judgment of a loving parent or parents who know and live with their own child, and are legally-presumed to love the child and act in the child's interests.

This letter does not endorse the effectiveness, or lack thereof, of "conversion therapy" itself. In Denver, the free market and patients themselves are already seemingly rejecting the practice, without any legal ban from City Council. Our clients have diverse opinions on the practice, but believe it should be the case-by-case individualized decision of the patient, the patient's parent(s), and the medical professional, not the State's.

Given that this particular type of treatment is currently rare within the borders of the City and County of Denver at this specific point in time, this bill is a solution in search of a problem. Politicians' desire to express their "intolerance for intolerance" could potentially result in these politicians needing medical treatment from contortions patting of themselves on the back after passing this bill. Obviously, the First Amendment exists to protect all speech--popular or unpopular-and stands for the proposition that the political fad of the day does not trump the fundamental constitutional rights to free speech and to parent one's own children.

Which is precisely the point: When Government inserts itself in between the sacrosanct, ancient, discreet, and constitutionally-protected relationship between doctor and patient, Government violates the Constitution. If Government is

allowed to ban conversion therapy today, tomorrow it will be allowed to ban other controversial or politically-unpopular medical treatments.

And ultimately, legal arguments aside, this bill does nothing to actually help or compensate any victims of conversion therapy. If a minor has been individually harmed by the therapy, under existing law, such victim can already bring a civil action or a formal administrative complaint with the licensing entity, either on his/her own behalf when reaching the age of majority, or through his/her parents while still a minor.

In fact, the bill does the opposite, compounding future harm by driving it underground. First, the bill only applies to licensed professionals, but allows conversion therapy by anyone unlicensed, who may be less responsible actors anyway as they are unlicensed and unregulated. Second, the bill is so broadly drafted, it arguably prevents even the therapeutic discussion of sex, "sexual orientation," "gender identity," "gender expressions," "sexual or romantic attractions," and even "feelings," all terms used in the bill, all subjects prohibited, and poorly defined, or completely undefined. Third, Americans have always been rebellious, and our cultural desire to rebel against arbitrary and powerful authority is literally the reason the United States of America was founded and exists. Thus, perversely, when Government bans a particular type of speech, such prohibition can unintentionally draw more attention and desire to engage in such speech. Like many past government efforts to ban particular books, it will have the opposite effect desired.

This bill would prohibit a licensed professional from discussion "that seeks to change an individual's sexual orientation or gender identity," adopting the definition of "gender identity" in D.R.M.C. § 28-92. It is probably not the intent of the drafters of this bill to enact a stealth prohibition against therapeutic discussion with transsexuals, gender transition, or those considering it, but this could be the actual result.

This language could prohibit a minor who is homosexual from discussing subjects of bisexuality, given the bill's one-way-ratchet, allowing therapeutic discussions where a heterosexual seeks to become a homosexual, but prohibiting discussions the other way, or overbroadly, any discussions that could "reduce sexual or romantic attractions or feelings toward individuals of the same gender." (emphasis added.) So, discussions with homosexuals under 18 who wish to experiment with bisexuality or heterosexuality will be prohibited and subject to

State punishment. For example, a heterosexual minor boy would be permitted to seek counseling to get over a difficult breakup with his "individual" girlfriend and "reduce her attractions or feelings towards her," but perversely, a homosexual minor boy could be denied treatment to get over a difficult breakup with his "individual" boyfriend and "reduce his attractions or feelings toward him." This viewpoint discrimination is counterproductive to the cause of equal rights for all sexual orientations, and is not permitted under the Constitution.

This is the legal flaw where Denver's proposal diverts from laws of other jurisdictions that have been upheld by other courts. In general, the bans that have been upheld, most notably California's SB 1172, did not discriminate by viewpoint. California law prohibits "sexual orientation change efforts" to minors by licensed professionals, and defines the term in a viewpoint-neutral fashion, thus prohibiting licensed professionals engaging in efforts to changing minors from heterosexual, bisexual, homosexual, or any other orientation. See Pickup v. Brown, 740 F.3d 1208 (9<sup>th</sup> Cir. 2014); Welch v. Brown, 834 F.3d 1041 (9<sup>th</sup> Cir. 2016).

Moreover, most of the previous caselaw concerns challenges brought under the free exercise of religion clauses of the First Amendment, not primarily under free speech and viewpoint discrimination principles. Finally, the U.S. Supreme Court has never ruled on the constitutionality of government prohibitions on therapeutic discussions in this specific context, but the U.S. Supreme Court dramatically altered the landscape in June 2018 with its NIFLA decision, which upheld the First Amendment rights of crisis pregnancy centers against compelled government speech advocating abortion, a procedure which such centers generally oppose.

Perhaps Denver's proposed one-way ban, which unjustifiably provides that helping to change a minor from bisexual to homosexual is acceptable and not harmful, but changing from homosexual to bisexual is harmful enough to result in actual government punishment, may be extreme enough to ultimately provide the U.S. Supreme Court with an opportunity to extend protections for freedom of speech.

When Government takes a sledgehammer to subtle and complex topics demanding a precise and fine scalpel, this is the inevitable result, and this is why there is a First Amendment at all. Prohibition of certain subjects of speech, and only one side of that subject, doesn't work.

The bill's vague and undefined prohibitions of certain subjects will exert a severe "chilling effect" on frank and candid discussions of even related topics by minors with their therapists. Most minors or adolescents, at some point, are inquisitive or even confused about sex and sexual matters before age 18. Some of these minors and their parents may seek formal counseling to discuss these matters, most will not. If this bill passes, such subjects are now prohibited or at least suspect, pigeonholed under the pervasive scrutiny of the State. Thus, the ultimate impact of this bill, as with most Government efforts to prohibit speech, will be to hamper and block discussion, and thus to slow real individual progress on these subjects. The bill gives Government the power to peek into, second-guess, and micromanage confidential and sensitive discussions that ought to remain private.

Additional points relating to the State prohibiting a particular medical treatment could fill many more pages. If this Bill passes, the City and County will be served with a lawsuit and injunction. See Elrod v. Burns, 427 U.S. 347 (loss of First Amendment freedoms, even for minimal periods of time "unquestionably" constitutes irreparable injury). If we are not granted an injunction, we will take this legal challenge as far as necessary.
