Amends Article IV of Chapter 27 of the Denver Revised Municipal Code (DRMC) relating to affordable housing to allow the execution of a performance deed of trust for settlements of disputed matters.

2. RR19 0092 DIA Angela Casias

Approves a lease agreement with Sky Chefs Inc. for rates and charges and for three years for approximately 16,780 square feet in the joint use cargo building to support catering operations for multiple airlines at Denver International Airport (201840776).
