## AMENDATORY AGREEMENT

THIS AMENDATORY AGREEMENT is made and entered into by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "City") and SAVATREE, LLC. DBA SWINGLE TREE AND LANDSCAPE CARE, INC., a Colorado Corporation (the "Contractor"), jointly "the parties."

## RECITALS

**A.** The Parties entered into an Agreement dated July 11, 2017 (the "Agreement") for the performance of certain work set forth in that Agreement and Exhibit A thereto; and

**B.** The Parties wish to amend the Agreement to update the Rates and extend the Term.

NOW, THEREFORE, the parties hereby amend the Agreement as follows:

**1.** All references to "Exhibit B" in the existing Agreement shall be replaced with Exhibit B-1." The Rates marked as Exhibit B-1 are attached hereto and incorporated herein by this reference.

2. Section 3 of the Agreement entitled "**TERM**" is amended to read as follows:

"3. <u>TERM</u>: The term of the Agreement runs from July 11, 2017 until June 1, 2020 or until the Maximum Contract Amount specified in sub-section 4.A below is expended, whichever is sooner, unless this Agreement is terminated earlier as provided in this Agreement or unless this Agreement is extended as provided in a separate amendment to this Agreement ("Term"). If the time needed to complete any Task Notice or amended Task Notice extends beyond the Term specified above, this Agreement shall remain in full force and effect but only as to such Task Notice or amended Task Notice; however, the total amount paid to the Contractor shall not exceed the Maximum Contract Amount specified in sub-section 4.A below."

**3.** Except as herein amended, the Agreement is affirmed and ratified in each and every particular.

4. This Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
