4 **A RESOLUTION**

5 **Laying out, opening and establishing as part of the City street system a parcel**
6 **of land as West Louisiana Avenue at the intersection of South Federal Boulevard**
7 **and West Louisiana Avenue.**

8 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has
9 found and determined that the public use, convenience and necessity require the laying out, opening
10 and establishing as a public street designated as part of the system of thoroughfares of the
11 municipality that portion of real property hereinafter more particularly described, and, subject to
12 approval by resolution has laid out, opened and established the same as a public street;

13 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

14 **Section 1.** That the action of the Executive Director of Public Works in laying out, opening
15 and establishing as part of the system of thoroughfares of the municipality the following described
16 portion of real property situate, lying and being in the City and County of Denver, State of Colorado,
17 to wit:

18 **PARCEL DESCRIPTION ROW NO. 2018-DEDICATION-0000181-001:**

19 A parcel of land conveyed by Special Warranty Deed to the City and County of Denver, recorded on
20 the 11th day of February 2019, at Reception No. 2019016861 in the City and County of Denver Clerk
21 and Recorder’s Office, State of Colorado, being more particularly described as follows:

23 A PARCEL OF LAND IN THE NORTHWEST QUARTER OF SECTION 20, TOWNSHIP 4 SOUTH,
24 RANGE 68 WEST OF THE 6TH PRINCIPAL MERIDIAN, CITY AND COUNTY OF DENVER, STATE
25 OF COLORADO, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

27 THE SOUTHERLY 3.00 FEET OF TRACT 17, GARFIELD HIEGHTS NEW FILING.

29 SAID PARCEL CONTAINS 835 SQUARE FEET (0.019 ACRES), MORE OR LESS.

34 CAP IN RANGE BOX LS #14592 AT THE NORTHEAST CORNER AND A FOUND 1" AXLE WITH
35 3" GEAR WITH 2" ALUMINUM TAG ATTACHED WITH WIRE IN RANGE BOX LS #16406 AT THE
36 EAST QUARTER CORNER

2 declared laid out, opened and established as West Louisiana Avenue.

3 **Section 2.** That the real property described in Section 1 hereof shall henceforth be known
4 as West Louisiana Avenue.
