A BILL

FOR AN ORDINANCE VACATING THAT PORTION OF THE PUBLIC ALLEY IN BLOCK 22, KASSERMAN'S ADDITION TO THE CITY OF DENVER, LYING BETWEEN THE NORTHEASTERLY LINE OF LOTS 1
TO 5, BOTH INCLUSIVE IN SAID BLOCK 22, AND THE SOUTHWESTERLY LINE OF LOT 8 IN WHEELER'S RESUBDIVISION OF A PORTION OF BLOCK 22, KASSERMAN'S ADDITION TO THE CITY OF DENVER, IN THE CITY AND COUNTY OF DENVER.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

WHEREAS, The Manager of Improvements and Parks has heretofore made the following order and direction, to-wit:

County of Denver at all times, the right to construct, maintain and remove sewers and water pipes and their appurtenances, and to authorize the construction, maintenance and removal of the same therein and thereon, and subject to the continued right of the owners to maintain and operate existing Electric Light and Power Lines, Gas Mains and Pipes.

And the Council of the City and County of Denver is hereby requested to give effect to this order by the passage of a suitable ordinance.


