JSCO will provide 3,350 hours of scheduled patrol during each calendar year; with increased schedules during spring and summer months; as well as certain specified holiday. Utilizing Jefferson County Sheriffs instead of Denver Police Officers on overtime staffing saves the Denver Police Department over \$100,000 in direct personnel cost over the three-year period.
