Per the City Council approved contract 201842934 (CB18-0855), this ordinance requests the creation of a new 29th and Fairfax Park capital fund (fund 38751) and subsequent appropriation as a follow up administrative financial action to receive and expend partner funds from PHC Mixed Use, LLC in the amount of \$650,000 for the design and construction of a park in the area of the 29th and Fairfax.
