
# Denver Eviction Pilot Project 2018

# Background

In April 2018, under the leadership of Council members Robin Kniech and Paul Kashmann, the Denver City Council donated funds to Colorado Legal Services to launch the Eviction Pilot Project. The project funded <u>one attorney</u> and <u>one paralegal</u> to provide legal assistance to tenants facing eviction at the Denver County Courthouse.

Total Eviction Process can be as little as 15 days, based on current state laws

# Highlights & Challenges

#### Highlights

- Collaborative effort between City of Denver Office of Economic Development (and TRUA funds), Colorado Poverty Law Project, Colorado Affordable Legal Services, Court Mediation Services, and Denver County Courts
- Counsel for landlords often agreed to a stipulation for time for tenants to move

#### Challenges

- Legislative limitations of the 3-day notice
- Costly, confusing and scary process for tenants
- There are not many legal remedies when only nonpayment of rent is at issue

#### Client Outcomes

Clients had to move, but no judgment was entered upon move out.

Clients retained housing **and** avoided a money judgment.

Judgment for possession entered

#### Outcomes, continued

78 clients received less than a month to move

21 clients received less than a week to move

4 clients received 1-3 months to move

In total, 73% of tenants had to move after an eviction filing

#### No eviction judgment on credit record


- Through the representation of Colorado Legal Services attorneys, and with the assistance of Project paralegals, these tenants entered into court stipulations that required the landlord to vacate the court judgment once the tenant moved.
- This is a vital outcome that enables these tenants to find another place to live, and prevents the "black mark" of a judgment on their credit record.

## Map of most zip codes served




A - 80219 B - 80205 C - 80204 D - 80203 E - 80231

#### Clients by Race/Ethnicity


Marital Status


