Scope of work:

The original Congress Park pool was built in 1955. The bathhouse and pool were later renovated in 1991. The pool is past its useful life and requires significant capital improvements each year to keep it operational. Replacement of the pool is needed to accommodate growth and recreational trends, incorporate contemporary technologies, as well as meet current compliance standards for pool safety and maintenance which was recommended as part of the 2014 Aquatics Master Plan. Program elements, site component relationships and context will be addressed during concept design.

The proposed renovations at Congress include:

- replacing the existing outdoor pools (50-meter lap and wading),
- creating a new pool deck, pool shell(s), piping, and recirculation systems, and
- replacing the existing bath house, filter house, building, and storage/picnic area with new facilities that better meet the needs of the public and staff.
