Denver Public Works, through its employees, enhances the quality of life in Denver by efficiently delivering effective, high-quality, safe, and equitable public infrastructure and services.

- Three-Step Approach
 - Realignment (February 2018)
 - Realign specific internal functions that do not impact day-to-day operations
 - Resolve current concerns
 - Executive priorities
 - Reorganization (August 2018)
 - Internal restructure that further aligns Transportation and Mobility resources
 - Refinement (August – December 2018)
 - Analyze and adjust reorganized department

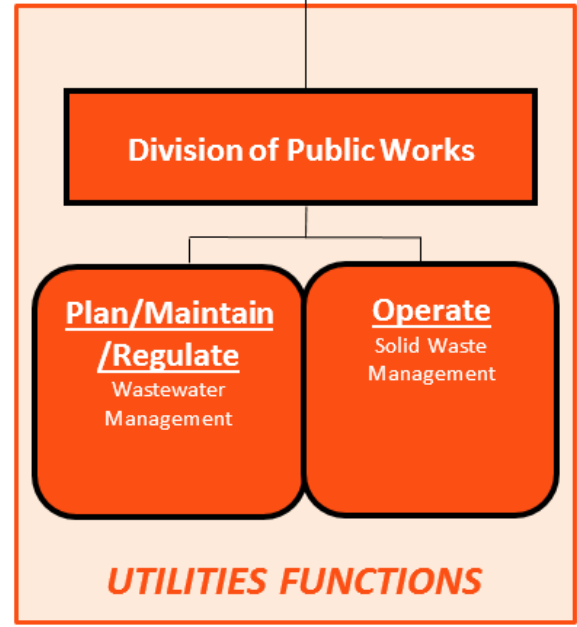
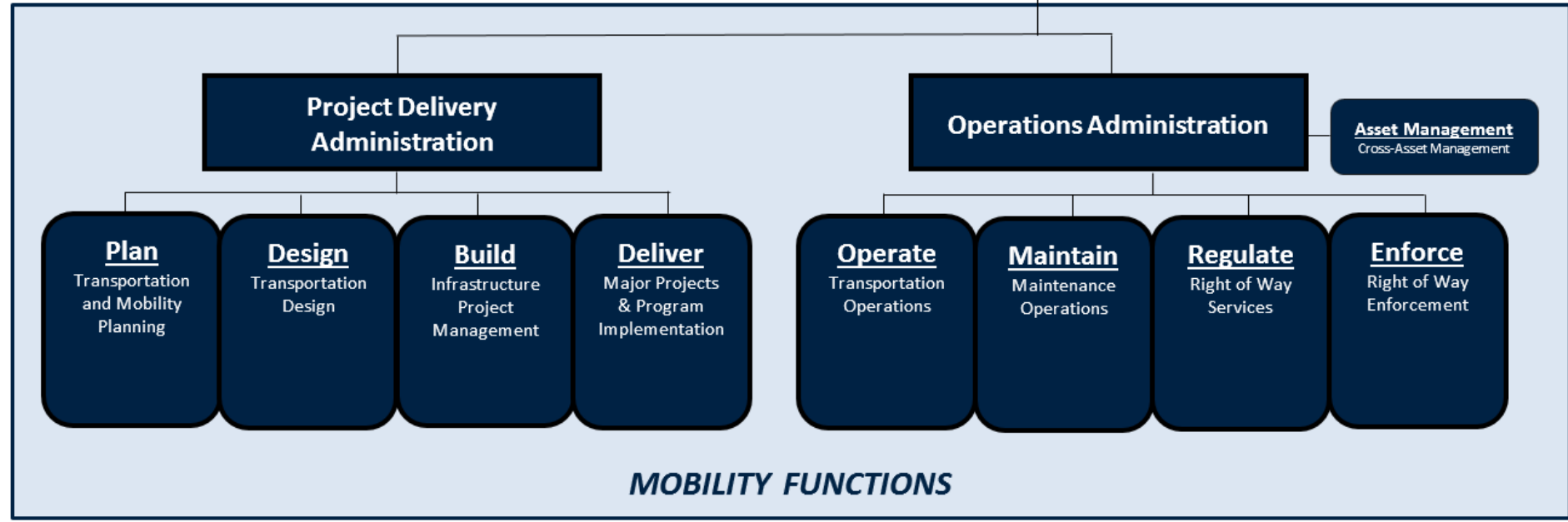
Creation of “Department of Transportation and Infrastructure” with an internal division of Public Works

Better defines the department’s activities in the charter by creating a single overarching department focused on mobility/infrastructure, with a separate internal division focusing on wastewater/solid waste services

Proposed DOTI Organizational Chart

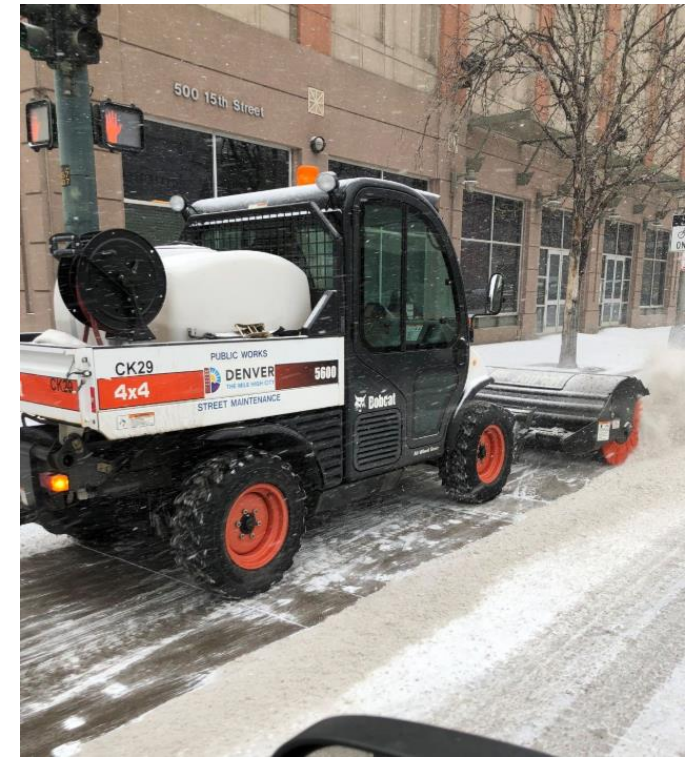

Department Creation Reasoning

- Communicates the city's commitment to expanding mobility options and improving existing transportation infrastructure
- Opportunity to update Public Works charter language to better reflect current and future duties and priorities (e.g. transit, safety)
- Elevates the need for efficient project delivery and avoids disruption of progress achieved through reorganization
- Avoids administrative duplications and corresponding cost of dividing department (estimated at \$7M/year)
- Facilitates coordination and synergy with divisions that impact transportation and infrastructure (e.g. Wastewater)



- Management, supervision and control of the designing, planning, construction, and reconstruction of all general public improvements (E.g roads, sewer/sanitary, bridges, public buildings)
- Supervision and management of local public improvement districts.
- Surveying functions
- Collection of sewage, trash, garbage, offal and other offensive substances
- Employment of professional and technical personnel



Substantive Charter Changes: New Language and Authorities

§ 2.3.1 - Creates a Department of Transportation and Infrastructure.

§ 2.3.3 - Powers and duties of Department of Transportation and Infrastructure.*

(D) Supervision and control of all **pedestrian facilities, bikeways and non-motorized trails in the right-of-way** (bike network)

(E) Ability to plan, build and operate **public transportation services**, either individually or jointly with the Regional Transportation District or any other public/private entity

(F) Responsibility for planning, building and operating of programs and public improvements related to enhancing **improving the safety of all users** of the right of way, including pedestrians, bicyclists, and motor vehicle operators



Reorganization of Duties within the Division of Public Works

§2.3.4 – Creates Division of Public Works within Department of Transportation and Infrastructure

- Duties and services that fall within the utilities administration (wastewater and solid waste management) are reorganized within Charter language under the Division of Public Works
- All existing duties and authorities of DPW are maintained with these Charter changes



- April 2nd - Media Announcement
- June 4th - LUTI Committee
- June 11th - Mayor Council
- June 17th - City Council 1st Reading
- June 24th - City Council 2nd Reading (Referral to Ballot)
- November 5th - Vote
- January 2020 – Charter Change Takes Effect if Approved, DOTI Established
