11	WHEREAS, pursuant to the provisions of Section 12-61 of the Denver Revised Municipal
12	Code ("DRMC"), and by Ordinance No. 302, Series of 2019, there has been approved a
13	Comprehensive Plan for the City and County of Denver ("Comprehensive Plan 2040"); and
14	WHEREAS, said Section 12-61 of the DRMC provides for the supplementation of
15	Comprehensive Plan 2040; and
16	WHEREAS, pursuant to the provisions of Section 12-61 DRMC, and by Ordinance No. 136,
17	Series of 2001, the City accepted the Stadium Area Plan as an amendment to the City's
18	comprehensive plan; and
19	WHEREAS, the City wishes to repeal and replace the Stadium Area Plan with an updated
20	comprehensive plan supplement entitled, Stadium District Master Plan for the orderly growth and
21	harmonious development of the City and County of Denver; and
22	WHEREAS, pursuant to the provisions of Section 12-61 DRMC, the City wishes to
23	supplement Comprehensive Plan 2040 by approving and accepting the Stadium District Master Plan;

25	WHEREAS, members of the City Council, duly authorized by the president of council have
26	monitored the process whereby said Stadium District Master Plan has been formulated; and
27	WHEREAS, the Stadium District Master Plan has been approved by the Denver Planning
28	Board; and
29	WHEREAS, the Manager of Community Planning and Development has transmitted the
30	Stadium District Master Plan to the Mayor and Council for acceptance as a supplement to
31	Comprehensive Plan 2040; and
32	NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF
33	DENVER;
34 35	<b>Section 1</b> . That the proposed Stadium District Master Plan, consisting of a document of the same name filed with the City Clerk, Ex-Officio Clerk of the City and County of Denver, on 20190047,

as City Clerk Filing No. June 3, 2019, is hereby adopted and accepted as a supplement to
Comprehensive Plan 2040, pursuant to Section 12-61(d) of the DRMC.

**Section 2**. That this adoption and acceptance of Stadium District Master Plan, and of any 3 amendment thereto, in conjunction with Comprehensive Plan 2040, is intended to establish the 4 official guide for officials of the City and County of Denver and private citizens when making decisions 5 affecting the future of land use and transportation in and for the City and County of Denver, as 6 defined in said plan; provided however, that such approval shall not preempt the decision making 7 8 powers vested by law or administrative directive in the Mayor, the Council or any other official of the 9 City and County of Denver with respect to, but not limited to: a zoning map amendment, a zoning language amendment, a dedication or vacation of a street, alley or other public way, a designation 10 of a park, the issuance of a revocable permit, a conveyance or acquisition of real property by the 11 12 City and County of Denver, or an appropriation for or construction of a capital improvement; and 13 provided, further that it is expressly understood that judgment must be exercised in the application 14 of Stadium District Master Plan in the decision making processes of the Mayor, Council and other 15 officials of the City and County of Denver. 16 COMMITTEE APPROVAL DATE: May 21, 2019
