**A BILL**

**For an ordinance approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and State of Colorado Department of Transportation concerning the “Evergreen Lake Road Bridge over Bear Creek” project and the funding therefor.**

**WHEREAS**, the City and County of Denver has given due consideration to said proposed Grant Agreement;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed Grant Agreement under CFDA No. 20.205, between the City and County of Denver and the State of Colorado Department of Transportation, for the “Evergreen Lake Road Bridge over Bear Creek” project, which is identified as Grant Number 19-HA1-XC-00063, a copy of which is duly filed with the City Clerk, Filing No. 201950183, be and hereby is approved in all respects.

**Section 2.** The payments made by the Colorado Department of Transportation to the City pursuant to and under the agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of the Department of Parks and Recreation, is as follows:

Expenditures of said funds are authorized upon execution of this agreement until March 27, 2029.  
The City will contribute matching funds of \$199,142.00.

3 to accomplish the purposes of this Ordinance.
