NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF

Section 1. That the proposed Far Northeast Area Plan, consisting of a document of the same
 name filed with the City Clerk, Ex-Officio Clerk of the City and County of Denver, on 20190045, as
 City Clerk Filing No. May 28, 2019, is hereby adopted and accepted as a supplement to
 Comprehensive Plan 2040, pursuant to Section 12-61(d) of the DRMC.

Section 2. That the Far Northeast Area Plan replaces and supersedes the Gateway Concept
Plan in its entirety.

9 Section 3. That the Far Northeast Area Plan replaces and supersedes the Montbello/Green
 10 Valley Ranch Neighborhood Plan in its entirety.

Section 4. That the Far Northeast Area Plan replaces and supersedes the 61st & Pena
 Station Area Plan in its entirety.

13 Section 5. That this adoption and acceptance of the Far Northeast Area Plan, and of any 14 amendment thereto, in conjunction with Comprehensive Plan 2040, is intended to establish the official guide for officials of the City and County of Denver and private citizens when making decisions 15 16 affecting the future of land use and transportation in and for the City and County of Denver, as 17 defined in said plan; provided however, that such approval shall not preempt the decision making 18 powers vested by law or administrative directive in the Mayor, the Council or any other official of the 19 City and County of Denver with respect to, but not limited to: a zoning map amendment, a zoning language amendment, a dedication or vacation of a street, alley or other public way, a designation 20 21 of a park, the issuance of a revocable permit, a conveyance or acquisition of real property by the 22 City and County of Denver, or an appropriation for or construction of a capital improvement; and 23 provided, further that it is expressly understood that judgment must be exercised in the application of the Far Northeast Area Plan in the decision making processes of the Mayor, Council and other 24 officials of the City and County of Denver. 25
