Dear Council President Jolon and Members of the Denver City Council:

I am unable to attend the Denver City Council meeting on Monday, June 17th but I wanted to express my support for the Stadium District Master Plan that you will be considering. For the last 6-9 months, I participated on the Steering Committee that helped guide the direction of the plan. As a property owner in the neighborhood (STEAM on the Platte), I joined the Committee because I care deeply about the future of Sun Valley. While the Sun Valley residential community and the Stadium have coexisted in the past, there has never been a discussion about how the neighborhood could redevelop in a way that benefitted and supported the whole neighborhood. I found this planning process (which was overseen by very competent City Planners, specifically Jason Whitlock and Sarah Cawrse) refreshingly open to the notion that this will be one neighborhood, not two. The representatives of both the Broncos and the Stadium District were genuinely open to the notion that their redevelopment would be more than an entertainment center, as other NFL Stadium projects have been and that a complete neighborhood would create a distinctive attraction for their fans. That openness on the part of the Broncos allowed for an open discussion about what it means to be part of a true neighborhood and the opportunities that existed for creating connections between the two activity areas. There was also a recognition of the importance of the Platte River to the community and a commitment to embrace it in the build out of the Stadium property. Finally, over the next few years as the entitlements to implement the plan are put in place, the conversation about Community Benefits will continue and I have no doubt that the partnership that has been created through this process provides a strong foundation for those important discussions.

I wholeheartedly encourage the Denver City Council to approve the Stadium District Plan, as presented.
