5 **A BILL**

6 **For an ordinance amending Ordinance No. 1250, Series of 2017, to change the**  
7 **budget basis of the “Public Health and Wellness” Fund and making an**  
8 **appropriation.**  
9

10 **WHEREAS**, the Public Health and Wellness Fund was established in Ordinance No. 1250 in  
11 the Series of 2017 to support public health-related programs; and

12 **WHEREAS**, the Ordinance established the fund as appropriated and lapsing; and

13 **WHEREAS**, the Denver Department of Public Health and Environment (DDPHE) has since  
14 determined that the on-going programs it administers in the fund do not necessarily align with the  
15 City’s fiscal year; and

16 **WHEREAS**, the DDPHE received \$100,000 from the Colorado Department of  
17 Transportation in 2018 that the department has not yet spent but now lacks the budget authority to  
18 do so due to the lapsing nature of the fund; and

19 **WHEREAS**, the DDPHE wishes to rectify this by changing the fund from lapsing to non-  
20 lapsing and appropriating the \$100,000 in revenue received;

22 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
23 **OF DENVER:**

25 **Section 1.** The portion of Section 4 of Ordinance No. 1250, Series of 2017, now reading:  
26

27 “Henceforth, all subsequent appropriations will be made in Denver’s Annual Appropriation  
28 Ordinance and this fund will be an appropriated, lapsing fund.”

30 Is hereby amended to read as follows:  
31

32 “Henceforth, all subsequent appropriations will be made in Denver’s Annual Appropriation  
33 Ordinance and this fund will be an appropriated, non-lapsing fund.”

**Section 2.** From the Public Health and Wellness Fund, Accounting No. 14806, out of monies not otherwise appropriated and in addition to the amounts heretofore appropriated by Ordinance No. 1280, Series of 2018, and any supplemental appropriations or rescissions there is hereby appropriated to the appropriation account hereinafter designated the amounts of money following each such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:

**Section 3.** The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
