COMMENCING AT THE INTERSECTION OF THE NORTH LINE OF THE SOUTH HALF (S ½) OF THE NORTHWEST QUARTER (NW ¼) OF SECTION 6, TOWNSHIP 4 SOUTH, RANGE 68 WEST OF THE 6TH PRINCIPAL MERIDIAN AND THE EXTENDED WEST LINE OF N WOLFF STREET PRODUCED SOUTH; THENCE SOUTH ON SAID EXTENDED WEST LINE OF N WOLFF STREET 46.75 FEET TO THE TRUE POINT OF BEGINNING;

THENCE CONTINUING SOUTH ON THE EXTENDED WEST LINE OF SAID N WOLFF STREET PRODUCED SOUTH APPROXIMATELY 553 FEET, TO THE NORTHERLY LINE OF THE RIGHT OF WAY OF THE DENVER AND INTERMOUNTAIN RAILROAD COMPANY;

THENCE EASTERLY ON SAID RIGHT OF WAY LINE TO A POINT 60.5 FEET EAST AT RIGHT ANGLES FROM AFORESAID PRODUCED WEST LINE OF N WOLFF STREET, SAID POINT BEING THE POINT OF INTERSECTION OF SAID RIGHT OF WAY LINE AND THE EXTENDED EAST LINE OF SAID N WOLFF STREET PRODUCED SOUTH;

THENCE NORTH ON THE PRODUCED EAST LINE OF SAID N WOLFF STREET EXTENDED FROM THE NORTH TO A POINT 46.16 FEET SOUTH OF THE NORTH LINE OF AFORESAID SOUTH HALF (S ½) OF THE NORTHWEST QUARTER OF SAID SECTION 6;

THENCE WEST OF SAID NORTH LINE 60.5 FEET, MORE OR LESS TO THE TRUE POINT OF BEGINNING.
