17	name of the fund to the "Business and Workforce Development Training, Support and Outreach"		
18	Fund and amend the original ordinance to clarify how the	e fund is currently used;

23	Section 1. The Special Revenue Fund currently	known as the "Denver Employment and	
24	Training Administration", Accounting No. 17904, establis	hed through Ordinance No. 288, Series of	
25	1984, shall henceforth be known as the "Business and V	Workforce Development Training, Support	
26	and Outreach" Fund.

28	Section 2. The portion of Section 2 of Ordinance No.	o. 288, Series of 1984, now reading:

30	"Expenditures are hereby authorized from the Ecor	nomic Opportunity Special Revenue Fund	
31	(Auditors No. 1700) in the amount not to exceed the	total deposits described in Section 1 of this	
32	ordinance, to be expended for the "DETA Special Pr	rojects" program, Auditor's No. 1724-9510,	
33	by the Mayor or his lawful successor or duly authoriz	zed agents."

"Expenditures are hereby authorized from the Economic Opportunity Special Revenue Fund, 4 5 Accounting No. 17000, in the amount not to exceed the total deposits described in Section 1 of this ordinance, to be expended for the "Business and Workforce Development Training, Support 6 7 and Outreach" Fund, Accounting No. 17904, by the Mayor or his lawful successor or duly 8 authorized agents. Allowable expenses include but are not limited to the costs to administer 9 programs related to training, outreach, and support for entrepreneurs, small businesses, and 10 workforce development efforts for youth and adults.

12 **Section 3.** The Chief Financial Officer of the City and County of Denver is hereby authorized 13 and directed to make such book and record entries and to do such other things as may be necessary 14 to accomplish the purposes of this Ordinance.
