**A BILL**

**For an ordinance establishing capital project funds in the Parks, Trails, and Open Space Capital Improvement Fund Series for the “Parks Debt Payments” program, the “Parks Citywide Projects” program, and the “Parks Improvement Projects” program.**

**WHEREAS**, the City Council approved Ordinance No. 0083, Series of 2019, which established the Parks, Trails, and Open Space Special Revenue Fund and appropriated \$37,014,414 for 2019 as part of the voter-approved ballot measure for acquiring land for parks, open spaces, and trails citywide; and

**WHEREAS**, the City Council approved Ordinance No. 0538, Series of 2019, which adopted the Denver Parks and Recreation 2A Five Year Plan (2020-2024) to utilize the funds from the 2018 Ballot Measure 2A Parks and Open Space Sales Tax; and

**WHEREAS**, companion ordinance CB19-0686 establishes the Parks, Trails, and Open Space Capital Improvement Fund to accept transfers from the Parks, Trails, and Open Space Special Revenue Fund for expenditures related to planning, design, and construction of capital projects; and

**WHEREAS**, this ordinance establishes three capital project funds that follow the same structure as in other capital improvement fund series used for expenditures related financial obligations, capital maintenance, and new capital project improvements; and

**WHEREAS**, the funds established through this ordinance enable annual reporting of expenditures consistent with the Parks, Trails, and Open Space Program Plan adopted by City Council in Ordinance No. 0583, Series of 2019;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** A new fund is hereby established in the Parks, Trails, and Open Space Capital Improvement Fund, Accounting No. 36000, “Parks Debt Payments”, Accounting No. 36015 for the

1 purpose of accounting for expenditures related to financial obligations related to parks, trails, and  
2 opens space capital projects. Expenditures are hereby authorized for the “Parks Debt Payments”  
3 Fund, Accounting No. 36015, to be expended by the Executive Director of the Department of Parks  
4 and Recreation. This is an appropriated, non-lapsing fund.

5 **Section 2.** A new fund is hereby established in the Parks, Trails, and Open Space Capital  
6 Improvement Fund, Accounting No. 36000, “Parks Citywide Projects”, Accounting No. 36045 for the  
7 purpose of accounting for expenditures related to capital maintenance activities. Expenditures are  
8 hereby authorized for the “Parks Citywide Projects” Fund, Accounting No. 36045, to be expended  
9 by the Executive Director of the Department of Parks and Recreation. This is an appropriated, non-  
10 lapsing fund.

11 **Section 3.** A new fund is hereby established in the Parks, Trails, and Open Space Capital  
12 Improvement Fund, Accounting No. 36000, “Parks Improvement Projects”, Accounting No. 36050  
13 for the purpose of accounting for expenditures related to planning, design, and construction of  
14 existing or new park, trails, or open space. Expenditures are hereby authorized for the “Parks  
15 Improvement Projects” Fund, Accounting No. 36050, to be expended by the Executive Director of  
16 the Department of Parks and Recreation. This is an appropriated, non-lapsing fund.

17 **Section 4.** Monies received into these three capital project funds from transfers from the Parks,  
18 Trails, and Open Space Special Revenue Fund, Accounting No. 15828, shall be deposited into the  
19 Treasury of the City and credited to Special Fund No. 36000, which is set forth and described in  
20 Section 20-18 of the Revised Municipal Code of the City and County of Denver.

21 **Section 5.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
22 and directed to make such book and record entries and to do such other things as may be necessary  
23 to accomplish the purposes of this Ordinance.
