A BILL

For an ordinance establishing a new fund in the Public Health Special Revenue Fund Series for the “Drug Strategy and Behavioral Health Donations Fund”, and transferring the cash balance associated with the “Drug Strategy and Behavioral Health Donations Fund” from the Human Services Special Revenue Fund Series.

WHEREAS, Ordinance No. 156, Series of 2004, created a “Drug Strategy Donations” Fund in the Human Services Fund Series; and

WHEREAS, when the Office of Behavioral Health Strategies transferred from the Department of Safety to Denver Human Services, this fund was expanded through Ordinance No. 414, Series of 2016, to allow for donations to support behavioral health, and the fund was renamed the “Drug Strategy and Behavioral Health Donations” Fund; and

WHEREAS, the Office of Behavioral Health Strategies transferred from Denver Human Services to the Denver Department of Public Health and Environment, Community and Behavioral Health Division in 2018; and

WHEREAS, a new Special Revenue Fund must be created in the Public Health Series to allow the Denver Department of Public Health and Environment to administer Drug Strategy and Behavioral Health programs supported by donations; and

WHEREAS, once said Special Revenue Fund is created in the Public Health Series, the cash balance in the existing Special Revenue Fund in the Human Services Series will be transferred to the new Fund; and

WHEREAS, once said cash is transferred, the Special Revenue Fund in the Human Services Series will no longer be required and will be closed;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

1 **Section 1.** A new fund is hereby established in the Public Health Special Revenue Fund Series,
2 Accounting No. 14000, a “Drug Strategy and Behavioral Health Donations Fund”, Accounting No.
3 14703, for the purpose of accounting for the receipt and expenditure of program dollars.

4 **Section 2.** Monies received from transfers from other City funds, donations, and other sources
5 of revenue for Accounting No. 14703 shall be deposited into the Treasury of the City and credited to
6 Special Revenue Fund No. 14000, which is set forth and described in Section 20-18 of the Revised
7 Municipal Code of the City and County of Denver.

8 **Section 3.** Program expenditures are hereby authorized for the “Drug Strategy and Behavioral
9 Health Donations Fund”, Accounting No. 14703, in the amount not to exceed the total of deposits
10 described in Section 2 of this ordinance to be expended by the Executive Director of the Denver
11 Department of Public Health and Environment. This fund is revenue-based and non-lapsing.

12 **Section 4.** There is hereby authorized the transfer of cash from the Human Services Special
13 Revenue Fund Series, Accounting No. 13000, to the Public Health Special Revenue Fund Series,
14 Accounting No. 14000, as indicated in the following tabulation:

19 due to transactions that may occur before the transactions in this ordinance can be executed.
