- Why we do a census:
- Article 1, Section 2 of the U.S. Constitution
  - The actual Enumeration shall be made within three Years after the first Meeting of the Congress of the United States, and within every subsequent Term of ten Years, in such Manner as they shall by Law direct.

The Decennial Census

- Conduct a census of population and housing Disseminate results to the President, the states and the American People
- Uses of Census data:
  - Draw congressional and state legislative districts, school districts and voting precincts
  - **Distribute** federal dollars to states
  - Inform planning decisions of federal, tribal, state and local government
  - Inform organizational decisions (e.g., where to locate, size of market, etc.) of businesses and non-profits



# Confidentiality



Census Bureau reputation depends on keeping data confidential. We take it very seriously!

- **Federal Law** Title 13 of the US Code protects the confidentiality of all information
- **Employee Oath** Protect confidentiality for life. Penalties if violated can be 5 years in prison and/or \$250,000 fine.
- **Statistical Safeguards** Ensure that statistics released do not identify individuals.






The U.S. Census Bureau uses TEA as the approach to conducting the 2020 Cen units in a given geographic area. The TEA assignment is based on area character respondent participation. The percentages below are an estimate of the number each TEA. The TEA delineation was conducted in 2018.

Housing Unit Percent Total	Type of Enumeration Area
95.32%	Self-Response
4.48%	Update Leave
0.17%	Military*
0.01%	Update Enumerate
0.02%	Remote Alaska

\*The depiction of TEAs within this viewer combines territory within the Military TEA with Self-Response in all areas except A combines territory within the Military TEA with Update Leave.

Self-Response is designed to occur in areas where the majority of housing unit delivered to the physical location of the housing unit. Self-Response is the prim methodology for the 2020 Census. Military enumeration is designed to occur i installations. Update Leave (UL) is designed to occur in areas where the major either do not have mail delivered to the physical location of the housing unit, or information for the housing unit cannot be verified. #### WHAT?

A CCC is comprised of a broad spectrum of government and community leaders from education, business, healthcare, and other community organizations. These trusted voices develop and implement a 2020 Census awareness campaign based upon their knowledge of the local community to encourage a response.

#### WHEN?

The formation of CCCs is happening NOW! Leaders are identifying budget resources and establishing local work plans. In 2020, they will implement the plans and lead their communities to a successful census count.
