11	WHEREAS, the agency known as Denver arts	and venues plays an integral role in promoting	
12	cultural and arts events in the community, administering the public art program, and in the		
13	management and control of city property used for theatre, concerts, conventions, and for other cultural		
14	purposes; and		
15	WHEREAS, on November 5, 2019, Denver arts and venues intends to seek electoral approval		
16	for revisions to city charter section 2.9.3 to conform the charter to certain historical practices.		
17	BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:		
18	Section 1. That section 2-191, D.R.M.C. shall	be amended by deleting the language stricken	
19	and adding the language underlined, to read as follows:		
20	Section 2-191. <u>Denver</u> Arts and Venues Denver		
21	Denver Aarts and venues Denver shall be the division	sion of general services responsible for <u>the</u>	
22	occupancy and operations, care, repair and maintenance, either by the agency, or under contract and		
23	the direction of the agency, of all facilities, structures, or parts of structures owned or leased by the		
24	City and County and used for theatre, concert, audit	orium, convention, or arena, or other cultural	
25	purposes, for management of the City and County cult	ural and arts events, and for administration of	
26	the public art program, creative sector development pr	ograms, and all related duties as described in	
27	this division. Denver Arts and Venues shall also have the management and control of all land on which		
28	such facilities or structures are located, and shall have	e the right to establish and make reasonable	
29	charges for the use of such facilities and structures. \mp	he division of <u>Denver</u> arts and venues Denver	
30	may perform other duties assigned by the mayor manager of general services not inconsistent with the		
31	Charter or the Code.		
32	Section 2. That section 2-192, D.R.M.C. shall	be amended by deleting the language stricken	
33	and adding the language underlined, to read as follows:		
34	Section 2-192. Director and other employees.		

35 (a) The position of director of <u>Denver</u> arts and venues Denver is hereby established as a position of

- 1 employment in <u>Denver</u> the arts and venues <u>Denver</u>.
- 2 (b) The <u>Denver</u> arts and venues Denver director shall <u>devote full time duties to the office and shall be</u>
- 3 an appointee of the mayor, serving at the pleasure of the mayor.be responsible to the manager of
- 4 general services for the performance of the functions, powers and duties assigned to arts and venues
- 5 Denver by this division, subject to and consistent with the provisions of the Charter.
- Section 3. That section 2-193, D.R.M.C. shall be amended by deleting the language stricken
 and adding the language underlined, to read as follows:

8 Section 2-193. Powers and duties.

- 9 (1) Work with the mayor, the city council, and all affected or interested departments, commissions, 10 boards, officers, offices, agencies and employees of the city in cultural development activities and in
- 11 operation and management of theatre, concert, auditorium, convention or arena venues; and
- 12 (2) Coordinate the activities of contractors and coordinate the various departments, commissions,
- 13 boards, officers, offices, agencies and employees of the city in the preparation of those activities; and
- 14 (3) Review and analyze provisions of ordinances, rules, executive orders and other regulatory
- 15 documents that may affect artistic activity in the city and advise the mayor and city council; and
- 16 (4) Administer the city's public art program, whereby a portion of capital improvement resource is
- 17 utilized for public art; and
- 18 (5) <u>Help to a</u>Attract <u>and retain</u> creative businesses and operations to Denver; and
- 19 (6) Act as liaison between the city and the Colorado <u>Cereative lindustries or its state-authorized</u>
- 20 successor; and
- 21 (7) Assist the Denver district county cultural council and the Denver metropolitan sScientific and
- 22 e<u>C</u>ultural f<u>F</u>acilities dDistrict with administration and distribution of revenues under state law; and
- 23 (8) Encourage the utilization of creative local professionals and businesses; and
- (9) Coordinate the efforts of <u>Denver</u> arts and venues in assisting increasing tourism and visitorship in
 the city; and
- 26 (10) Provide technical assistance and information to arts and cultural groups concerning funding,
- 27 grants, loans, and other forms of assistance available to them; and
- (11) Promote the venues and arts of the city to connect community members and visitors with
 Denver's arts and entertainment sector; and
- 30 (12) Encourage the incorporation of art in privately funded activities and capital improvements; and
- 31 (13) Work with the departments designated by <u>c</u>Charter to acquire and construct all facilities,
- 32 structures, or parts of structures owned or leased by the city and county and used for theatre, concert,
- 33 auditorium or arena purposes; and
- 34 (14) Maintain, repair, manage and operate all facilities, structures, or parts of structures owned or

- 1 leased by the city and county and used for theatre, concert, auditorium, convention, or arena
- 2 purposes; and
- 3 (15) Perform centralized administrative functions for all arts and venues facilities, including budgeting,
- 4 revenue receipt, and coordination of capital improvements; and
- 5 (16) Provide event support services, including booking, contract administration, ticketing, customer
- 6 service, parking, and production services; and
- 7 (17) Oversee the utilization of city venues and generation of revenue by promoting cultural tourism;
 8 and
- 9 (18) Develop policies and procedures for fair corporate access to sponsorships of city events, arts,
 10 and venues; and
- 11 (19) Develop financial processes with a goal of maintaining and preserving the agency's venues-: and
- (20) Offer free and low cost cultural programs for the enjoyment and enrichment of residents and
 visitors of the city.
- Section 4. That section 2-194, D.R.M.C. shall be amended by deleting the language stricken and adding the language underlined, to read as follows:

16 Section 2-194. Rules and regulations.

- The <u>Denver</u> arts and venues director is hereby delegated the authority to promulgate such rules and regulations and informal guidelines as may be necessary or desirable to effect the purposes of this division of the code.
- 20 **Section 5.** That section 2-275, D.R.M.C. shall be amended by deleting the language stricken 21 and adding the language underlined, to read as follows:

22 Section 2-275. Procedure for naming buildings other than fire houses.

23 (b) Buildings other than fire houses and major components of buildings other than fire houses shall 24 only be named for outstanding persons who have been influential in the cultural, political, economical 25 or social life of the community or in recognition of an individual or corporation which has contributed 26 substantial funding for the construction of the public buildings or major component of public buildings. 27 In addition, major components of buildings managed by the director of the division of Denver arts and venues Denver, or other designee of the manager of the department of general services, pursuant to 28 29 section 2.9.3(E) of the Charter ("theatres and arenas facilities"), may be named in recognition of 30 substantial financial contributions to the city by individuals or entities for the administration, 31 construction, management, maintenance, operation or repair of theatres and arenas facilities.

32 **Section 6.** If any section, paragraph, clause, or other portion of this ordinance is held to be 33 invalid or unenforceable for any reason, the validity of the remaining portion of this ordinance shall not
