7 **Approving and providing for the execution of a proposed grant agreement**
8 **between the City and County of Denver and the United States of America**
9 **Department of Health and Human Services concerning the "Head Start FY19-**
10 **20" program and the funding therefor.**

12 **WHEREAS**, Ordinance No. 0290, Series of 2019, authorized expenditures of \$7,690,277,
13 which represents 80 percent of the \$9,612,847 FY2019-2020 Head Start award, identified in a
14 letter of intent from the United States Department of Health and Human Services, which was filed
15 with the City Clerk under Filing No. 19-0014; and

16 **WHEREAS**, the City and County of Denver has given due consideration to said proposed
17 Grant Agreement;

19 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**
20 **OF DENVER:**

22 **Section 1.** The proposed Grant Agreement, under CFDA No. 93.600, between the United
23 States of America and the City and County of Denver, which is identified as Grant Number
24 08CH010552-02-00, a copy of which is duly filed with the City Clerk, Filing No. 2019-48325-00,
25 be and hereby is approved in all respects.

26 **Section 2.** The payments made by the United States of America to the City pursuant to and
27 under the Grant Agreement shall be deposited into the Treasury of the City and credited to
28 Special Fund No. 11000, which is set forth and described in Section 20-18 of the Revised
29 Municipal Code of the City and County of Denver.

30 **Section 3.** That it be and is hereby found and determined that the budget summary of said
31 "Head Start FY19-20" Program, Accounting No. 11002-0104100-AWD-00000793 is as follows, to
32 be expended by the Director of the Office of Children's Affairs:

1 The foregoing authorization will provide services (education, nutrition, health, mental health,
2 disabilities and family services) to 1,153 eligible children. Authorization for expenditure of said
3 funds following execution of said grant will cover the period from July 1, 2019 to June 30, 2020.

4 **Section 4.** The Chief Financial Officer of the City and County of Denver is hereby
5 authorized and directed to make such book and record entries and to do such other things as
6 may be necessary to accomplish the purposes of this Resolution.
