Briefing from Kirsten Crawford: Peer Cities

- Reached out to contacts in various cities and organizations
- Colorado Springs, CO
 - Analogous to Denver because it was formed under the same constitutional measure as Denver
 - o Talked to City Attorney Wynetta Massey
 - Meeting with them on Thursday, August 15th to go over the history of organizational change
 - Changes happened in 2008/09 that made the city structure go from council/manager to council/mayor form of government
 - o Additional changes occurred in 2012 to give council more authority
- International Municipal Lawyers Association
 - o Talked to Executive Director, Chuck Thompson
 - Chuck Thompson is happy to be a resource and would like to schedule a phone call/conference call with committee to answer questions
 - o Mentioned Jacksonville, FL and Tulsa, OK as other cities to look into
- Baltimore, MD
 - Made an organizational change to have legislative counsel move from City Attorney's Office into City Council Office
 - Solicitor of Baltimore feels that this was to the detriment of City Council as it siloed their Legislative Counsel
 - Kirsten will talk to more people in Baltimore to get a better understanding of the new dynamics

 - Will do further research

- External/Independent agencies include: Clerk and Recorder, Auditor, the Courts, INC, Fire and Police unions, and AFSCME
- Deadline for council offices to submit ideas is flexible
 - Have research requests to Emily by September 23rd
- Add to form the following questions:
 - "What is the problem you are trying to solve?"
 - o "Is this the best way to solve this problem?"
- Be sure central staff tracks all requests
 - Central staff will work with Legislative Counsel on applicability of request to the Charter – is this best as a Charter change or DRMC change?
- Councilmembers should only submit 1 idea each to ensure central staff has the capacity to do quality research and evaluation
- External partners need to do their own research and complete the Charter Change Request Form

Discussion of Operations of Committee

- Charter Review Committee will be first round of vetting ideas and asking for revision and addressing concerns that councilmembers may have with proposed charter changes.
- These ideas will then go to FINGOV and then onto the dais
- Should committee be televised?
 - Will be discussed in Operations on Wednesday August 21
- Should central staff send out calendar invites to each councilmember for this committee?
 - Legislative staff stopped sending out calendar invitations for standing meetings since they notify council of meetings every Thursday
 - Will discuss further with central staff and Council President Clark.

Public Engagement

- Once ideas are ready to be discussed each meeting will have 15 minutes of public comment
- Need to figure out how to engage public further:
 - Once ideas are solid, take them on the road?
 - o Host community meetings?
 - By district? By quadrant?
 - Who is responsible for organizing these events, paying for these events, and coordinating with the community?
 - Leg staff? Individual council offices?
 - o What does this engagement timeline look like?
