


DENVER Overview of People Experiencing Homelessness in Denver

- 3,943 people experienced homelessness on a single night in Denver (2019 PIT)
 - 3,145 single adults (79%)
 - 798 people in families (20%)
 - 8 youth under 18 (0.2%)
- 806 reported experiencing chronic homelessness (20%)
- **428** reported being newly homeless (11%)
- **494** reported being veterans (14%)
- **196** were unaccompanied or transition age youth (6%)

Three-Year Shelter Plan

 The City partnered with a nationally recognized homeless services contractor to work alongside providers and identify shelter needs and offer recommendations.

Single adult shelter configuration does not serve all subpopulations

 While analysis showed adequate static capacity of beds, beds are not configured to meet all demographic needs

Cumbersome and timeconsuming staging and bussing

 Analysis demonstrated that shelter guests could spend between 1.5 and 8 hours navigating transport to shelter

Lack of focus on exits and connections to rehousing


Overnight services

Community Needs

Crossroads provides important capacity to the shelter network.

- In the first six months of 2019, **986** brand new guests have been identified at Denver Rescue Mission.
 - These are people with no prior history of service at DRM in the last decade or so.
 - The baseline bed capacity at Denver Rescue Mission programs is 1,000, so this reflects approximately a 100% turnover in 6 months (disregarding diversity of length of stay).
 - This is a rate of about 5-6 new guests arriving each day.
- Crossroads currently provides nearly 1/3 of the nightly emergency shelter beds for single men.
- Providers would not be able to absorb peak demand levels through the year without Crossroads operating.





Acquisition Opportunity

- Crossroads location is critical:
 - The location provides support that is walkable to jobs and resources.
 - The location currently shelters up to 476 guests without the need to bus.
 - We do not currently have the ability to scale bus transportation nor do we have facility infrastructure to support expanded bus programming.
- Shelter usage data demonstrates this shelter capacity is needed today.
- Acquisition paves the way for future uses consistent to the 3-year Shelter Recommendations.

Funding and Process

- The City will purchase the building from The Salvation Army in the amount of \$10,500,000.
- Funding for the acquisition will be provided through three sources:
 - Community Development Block Grant: \$4 million
 - Skyline Grant Funds: \$3 million
 - General Fund Supplemental: \$3.5 million (pending council action).



Next Steps 1-3 Years

- Upon acquisition, the shelter will continue to operate during existing shelter hours for community needs.
 - HOST will present an amended service agreement for review and approval at Safety and Housing committee in the coming weeks.
- Shelter will transition any remaining mats on the floor to beds/cots.
 - Funded through a proposed \$200K General Fund Supplemental (pending council action.)
- City will engage with the neighborhood regarding shelter operations.
- Initiate design to start renovations to provide upgraded infrastructure including HVAC and furniture updates.
- Medium and long-term uses for the site will be determined with stakeholder input and align with the 3-year shelter strategy.





Request for Approval

- The Division of Real Estate requests City Council approval of action item RR19 0836, approving a purchase and sale agreement with The Salvation Army, for \$10,500,000 to acquire property located at 1901 29th Street, known as the Crossroads shelter, to preserve the City's current shelter needs, in Council District 9 (FINAN-201951595).
- This action allows the City to secure this facility, provide overnight shelter for individuals experiencing homelessness, and ensure uninterrupted shelter services for the community.
