**Section 1.** A new fund is hereby established in the Grant and Other Money Projects Fund, Accounting No. 38000, "Denver Water/NWC Recycled Water Pipeline IGA", Accounting No. 38429, for the purpose of accounting for capital expenditures related to planning, design, and construction of recycled water infrastructure in the National Western Center project.

Section 2. Monies received from Denver Water donations shall be deposited into the Treasury of the City and credited to Special Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.
