The fees generated by this District will close the funding gap for expansion of the Colorado Convention Center (CCC), provide funds for future improvements at the CCC and support marketing efforts. Qualifications for appointment is that each member shall be an "elector" of the District. "Elector", for this purpose, means individuals who pay taxes either as an owner or operator of a lodging business within the District. The district will provide a nomination recommendation to the Mayor's Office.
