Section 1. That the proposed Loretto Heights Small Area Plan, consisting of a document of the same name filed with the City Clerk, Ex-Officio Clerk of the City and County of Denver, on August 19, 2019, as City Clerk Filing No. 20190071, is hereby adopted and accepted as a supplement to Comprehensive Plan 2040, pursuant to Section 12-61(d) of the DRMC.

Section 2. That this adoption and acceptance of the Loretto Heights Small Area Plan, and of any amendment thereto, in conjunction with Comprehensive Plan 2040, is intended to establish the official guide for officials of the City and County of Denver and private citizens when making decisions affecting the future of land use and transportation in and for the City and County of Denver,

1	as defined in said plan; provided however, that such approval shall not preempt the decision making		
2	powers vested by law or administrative directive in the Mayor, the Council or any other official of the		
3	City and County of Denver with respect to, but not limited to: a zoning map amendment, a zoning		
4	language amendment, a dedication or vacation of a street, alley or other public way, a designation		
5	of a park, the issuance of a revocable permit, a conveyance or acquisition of real property by the		
6	City and County of Denver, or an appropriation for or construction of a capital improvement; and		
7	provided, further that it is expressly understood that judgment must be exercised in the application		
8	of Loretto Heights Small Area Plan in the decision making processes of the Mayor, Council and other		
9	officials of the City and County of Denver.
