As a part of the creation of the Department of Housing Stability (HOST) in the 2020 Budget, funding that supports staffing and programs dedicated to individuals experiencing homelessness is moving from Denver Human Services (DHS) to HOST. As part of this move, the Emergency Solutions Grant program that is currently administered by Denver Human Services through the Emergency Shelter Fund in the Human Services Special Revenue Fund Series will be administered by HOST. This requires creating a new grant fund in the Community Development Special Revenue Fund Series.
