5 **A BILL**

6 **For an ordinance assessing the annual costs of the continuing care, operation,**
7 **repair, maintenance and replacement of the Expanded Greektown Pedestrian**
8 **Mall Local Maintenance District upon the real property, exclusive of**
9 **improvements thereon, benefited.**

11 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

12 **Section 1.** Upon consideration of the recommendation of the Manager of Public Works that
13 an ordinance be enacted for the purpose of assessing the annual costs of the continuing care,
14 operation, repair, maintenance and replacement of the Expanded Greektown Pedestrian Mall Local
15 Maintenance District (“Expanded Greektown Pedestrian Mall”), for the upcoming year, upon the real
16 property, exclusive of improvements thereon, benefited, the Council finds, as follows:

17 (a) A local maintenance district providing for the continuing care, operation, repair,
18 maintenance and replacement of the Expanded Greektown Pedestrian Mall, was created by
19 Ordinance No. 656, Series of 1998;

20 (b) The annual cost of the continuing care, operation, repair, maintenance and
21 replacement of the Expanded Greektown Pedestrian Mall is \$30,500.00, which amount the Manager
22 of Public Works has the authority to expend for the purposes stated herein;

23 (c) The Manager of Public Works has complied with all provisions of law relating to the
24 publishing of notice to the owners of real properties to be assessed and to all persons interested
25 generally, and the Council sitting as a Board of Equalization has heard and determined all written
26 complaints and objections, if any, filed with the Manager of Public Works;

27 (d) The real property within the Expanded Greektown Pedestrian Mall will be benefited in
28 an amount equal to or in excess of the amount to be assessed against said property because of the
29 continuing care, operation, repair, maintenance and replacement of said Expanded Greektown
30 Pedestrian Mall.

31 **Section 2.** The annual cost of the continuing care, operation, repair, maintenance and
32 replacement of the Expanded Greektown Pedestrian Mall to be assessed against the real properties,
33 exclusive of improvements thereon, benefited are hereby approved.

34 **Section 3.** The annual costs of the continuing care, operation, repair, maintenance and
35 replacement of the Expanded Greektown Pedestrian Mall in the amount of \$30,500.00 are hereby

1 assessed against the real properties, exclusive of improvements thereon, within said local
2 maintenance district as follows:

3 NOTE: Where a series of lots is followed by "inclusive", the amount appearing after the series shall
4 be the total for all lots in the series. Where a series of lots is not followed by "inclusive", the amount
5 appearing after such series shall be the assessment for each lot in the series.

17 **Section 4.** The assessments made pursuant hereto shall be a lien in the several amounts
18 assessed against each lot or tract of land set forth in Section 3 herein, and such lien shall have the
19 priority of the lien for local public improvement districts.

20 **Section 5.** Without demand, said assessments as set forth in Section 3 herein, shall be due
21 and payable on the first day of January of the year next following the year in which this assessing
22 ordinance became effective, and said assessments shall become delinquent if not paid by the last
23 day of February of the year next following the year in which this assessing ordinance became
24 effective. A failure to pay said assessments as hereinabove set forth shall become a lien on the
25 property subject to the assessment, and such lien may be sold by the City as provided by the Charter
26 and ordinances of the City and County of Denver.

27 **Section 6.** Any unspent revenue and revenue generated through investment shall be
28 retained and credited to the Expanded Greektown Pedestrian Mall Local Maintenance District for
29 future long term or program maintenance of the District.
