DSBO is committed to addressing these recommendations by making changes to the Ordinance, Rules and Regulations and internal policy & procedures. DSBO continues to engage the community and business owners to prioritize recommendations.

Amendments to the DSBO Ordinance will extend the DSBO program for six months to allow for more time to discuss community recommendations to the DSBO program and identify needed changes to the Ordinance, Rules and Regulations or internal policies and procedures.
