#### FIRST AMENDMENT to the Dark Fiber Lease Agreement No. CO-RTimmo-112117-01

Whereas, the Parties desire to amend the Agreement by this writing to reflect the amended or additional terms and conditions to which the Parties have agreed to;

Now, therefore, in consideration of the promises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

- The City may place orders for additional Facilities from Company via the City's Purchase Order(s) ("Purchase Order(s). Any such Purchase Order(s) shall: (i) reference the Agreement No. CO-RTimmo-112117-01, and (ii) be subject to the General Terms and Conditions set forth in the Agreement.
- 2. Purchase Order(s) for additional Facilities shall not exceed the Maximum Contract Amount, pursuant to Section 31 of the Agreement.
- 3. Except as herein amended, the Agreement is affirmed and ratified in each and every particular.
- 4. This Amendment is not effective or binding on the City until it has been fully executed by all required signatories of the City, and if required by Charter, approved by the City Council.
