SECOND AMENDMENT

to

Services Agreement No. CO-64473-022316-01

This Second Amendment ("Amendment") made effective as of August 8, 2019 ("Effective Date") modifies and amends Services Agreement No. CO-64473-022316-01, to include any preceding Amendment(s) thereto (collectively "Agreement") by and between Comcast Cable Communications Management, LLC ("Comcast") and the City and County of Denver, a Colorado home rule municipal corporation on behalf of the Denver Public Library ("Customer"), individually referred to herein as "Party" and jointly referred to as "Parties". In the event of an explicit conflict between this Amendment and the Agreement, the terms and conditions of this Amendment shall take precedence in the interpretation of the explicit matter in question. Unless otherwise set forth herein, all capitalized terms set forth herein shall have the same meaning as set forth in the Agreement.

Whereas, Customer and Comcast have previously entered into the Agreement and whereby Comcast agreed to provide Customer the Services more particularly described therein;

Whereas, the Parties desire to amend the Agreement by this writing to reflect the amended or additional terms and conditions to which the Parties have agreed to:

Now, therefore, in consideration of the mutual covenants, promises, and consideration set forth in this Amendment, the Parties agree as follows:

- 1. At the request of the Customer, Comcast shall provide a Static IP Block/27 (30) for one (1) existing 4000 Mbps EDI Services circuit, as set forth in the Sales Order Form(s) attached hereto.
- 2. The additional MRC throughout the remainder of the Agreement Service Term for the Static IP referenced herein shall be \$50.00. The current total MRC for all Services under the Agreement is \$51,074.00 which shall increase to a revised total Agreement MRC of \$51,124.00 upon the completion of this Services upgrade. The Maximum Annual Contract Amount set out in Article 11.15 shall be increased to \$613488 and the Maximum Contract Amount shall be increased to \$3,065,050.00.
- 3. The Estimated Service Date for the Services detailed herein shall be on or after July 1, 2020.
- 4. This Amendment shall commence as of the Effective Date set forth herein and is coterminous with the original Agreement.

IN WITNESS WHEREOF, the Parties hereto have executed this Amendment as of the day and year written below and the persons signing covenant and warrant that they are duly authorized to sign for and on behalf of the respective Parties. Except as otherwise modified by this Amendment, all other terms and conditions set forth in the Agreement shall remain in full force and effect.
