Section 2. Monies received from partner organizations or private entities shall be deposited into the Treasury of the City and credited to Special Fund No. 38000, which is set forth and described

in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. Expenditures are hereby authorized for the "Parks and Recreation Capital Contributions" Fund, Accounting No. 38705, in the amount not to exceed the total of deposits described in Section 2 of this Ordinance, to be expended by the Executive Director of the Department of Parks and Recreation. Authorized expenditures for Accounting No. 38705 include capital improvements, such as planning, design, or construction activities for Parks and Recreation capital projects. This is a revenue-based, non-lapsing fund.

Section 4. The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
