## **EXECUTIVE SUMMARY**

This creates an amended \$597,507 contract between the Department of Housing Stability (HOST) and Colorado Legal Services. This amendment adds \$297,517 to the existing 2019 amount of \$299,990 for a total amount of \$597,507 and extends the contract through December 31, 2020.

These funds will be provided to Colorado Legal Services to be utilized for the Legal Services to Low-Income Tenants Program. Lawyers and a paralegal will provide free legal assistance, including in-court eviction representation, to lowincome persons and other members of vulnerable populations in an effort to prevent homelessness and stabilize residents in their homes. This program serves City and County of Denver households earning 80% of the area median income or below.

This \$597,507 contract is expected to serve approximately 1,100 low-income households by December 31, 2020.
