22	Denver Revised Municipal Code, for Accounting No. 11	877 shall be deposited into the Treasury of	
23	the City and credited to Special Revenue Fund No. 1100	0, which is set forth and described in Section	
24	20-18 of the Revised Municipal Code of the City and Co	ounty of Denver.	

Fund is revenue-based and non-lapsing.

Section 4. The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.

Section 3. Program expenditures identified in Chapter 48, Article IX of the Denver Revised

Municipal Code are hereby authorized for the "Disposable Bag Fee" Fund, Accounting No. 11877,

in the amount not to exceed the total of deposits described in Section 2 of this ordinance to be

expended by the Executive Director of the Department of Transportation and Infrastructure. This
