21	Section 2. That the zoning classification of the land area in the City and County of Denver			
22	described as follows shall be and hereby is changed from U-SU-C to U-SU-C1:			
23 24 25	Lots 3 and 4, Except the rear or Easterly 8 feet thereof, Block 4, Sloan Lake Park City and County of Denver, State of Colorado			
26	in addition, thereto those portions of all abutting public rights-of-way, but only to the centerline			
27	thereof, which are immediately adjacent to the aforesaid specifically described area.
